

RESIDENT BEACH & TRANSFER STATION STICKER APPLICATION

PLEASE READ INSTRUCTIONS CAREFULLY BEFORE FILLING OUT APPLICATION

1. **ALL VEHICLES:** Enclose copy of registration and same name driver's license for each vehicle getting a sticker.
2. **LEASED VEHICLES :** Enclose a copy of the lease agreement showing name & vehicle ID.
3. **COMPANY VEHICLES :** Enclose on company letterhead authorization stating vehicle is for personal use with registraton & license copies.
4. **APPLICATION MUST BE POSTMARKED NO LATER THAN MARCH 1 in order to receive discounted sticker prices.**
 *Discounts do **not** apply to walk-in applications, senior rates or separate purchases of beach and transfer stickers.
Senior rates are pre-discounted and apply to individuals aged **62** and older **at time of purchase**.
 "SECOND" TRANSFER STICKERS : Before March 1st = \$15.00 : After March 1st = \$ 25.00
5. **MAIL APPLICATION TO :** RESIDENT STICKER DEPT, **TOWN OF DUXBURY**, 878 TREMONT ST, DUXBURY, MA 02332
 A self-addressed stamped return **# 10 ENVELOPE** MUST be sent with payment or stickers will be held for pick-up.
6. **MAKE CHECKS PAYABLE TO :** TOWN OF DUXBURY Temporary and out-of-state checks will **not** be accepted.
7. **STICKERS ARE VALID FROM :** April 1, 2007 through March 31, 2008.
8. **HOUSEHOLD STICKER LIMIT : 3 for BEACH:** (with maximum of **2 Oversand**) ; **2 for TRANSFER**
9. **STICKERS ARE NON-TRANSFERABLE AND NON-REFUNDABLE .** If vehicle is **sold** or **destroyed** in an accident, old sticker(s) **MUST** be returned for a replacement fee of \$10 each. Full price is charged if sticker is not returned.
10. **IF RENTING YOUR HOME:** Please plan your beach sticker purchases accordingly (re-read LINE 8); a renter must provide a written and signed rental agreement, (copy of) registration and (copy of) driver's license.
