

RESIDENT BEACH and TRANSFER STATION STICKER APPLICATION

* * * PLEASE READ INSTRUCTIONS BEFORE COMPLETING APPLICATION * * *

1. **ALL VEHICLES:** Enclose copy of registration and same name driver's license for each vehicle getting a sticker.
2. **LEASED VEHICLES:** Enclose copy of lease agreement showing name & vehicle ID.
3. **COMPANY VEHICLES:** Need company letterhead authorization that car is for personal use with copies of registration & license.
4. **APPLICATIONS MUST BE POSTMARKED NO LATER THAN MARCH 1 to receive \$20 beach sticker discount.**
*Discounts do **not** apply to **walk-in** applications or **senior** rates. Senior rates apply to individuals aged 62 and older **at time of purchase**.
5. **MAKE CHECKS PAYABLE TO: TOWN OF DUXBURY.** Temporary - OR - Out of State checks will not be accepted.
6. **MAIL APPLICATION TO: RESIDENT STICKER DEPT, TOWN OF DUXBURY, 878 TREMONT ST, DUXBURY, MA 02332**
A self-addressed stamped return envelope **MUST** be sent with payment or stickers will be held for pick-up.
7. **HOUSEHOLD STICKER LIMIT:** 3 for BEACH (maximum 2 OVERSAND) ; 2 for TRANSFER
8. **STICKERS ARE NON-TRANSFERABLE AND NON-REFUNDABLE.** If vehicle is **sold** or **destroyed** in an accident, old sticker(s) **MUST** be returned for a replacement fee of \$10 each. Full price is charged if sticker is not returned.
9. **IF RENTING YOUR HOME:** Please plan your beach sticker purchases accordingly (see LINE 7):
A renter must provide a written and signed rental agreement, with registration and license.
